### Funding announcement:

As you will be aware by now, the DfE have announced the 75 upper tier local authorities who are eligible to receive funding to ‘transform Start for Life and Family Hub services’, [www.gov.uk/government/publications/family-hubs-and-start-for-life-package-methodology-for-pre-selecting-local-authorities](http://www.gov.uk/government/publications/family-hubs-and-start-for-life-package-methodology-for-pre-selecting-local-authorities)

With less than 30% of LAs in the South East selected, the majority of LAs in the region will be deciding what this means for their family hub development. We already know that many LAs are committed to transforming the way they meet local need and the integration of services is part of this approach. For others, lessons learnt during Lockdowns in the pandemic, have given opportunities to widen virtual and digital options, for example. There is also scope for wider regional collaboration and sharing ways of effective working are all part of this. Whilst some of you are still waiting on the DfE's announcement of the Transformation Bid, we wanted you to know that Carly and Julie are here to support all our LAs, regardless of funding status and we really appreciate lots of you being in touch over the last couple of weeks.

Early Help or Help in the Early Years?

*It is hard to argue with the call for better universal provision for families in the first 1001 days from a child's conception. Good, compassionate support for mothers and their partners through pregnancy, and the first two years of a child's life, is particularly important when the going gets tough and the messages become hard to deliver and equally hard to hear. The Best Start for Life is a vision that is easy to share.*

*But is there a risk that a strengthened offer for the youngest children may impact on an area's capacity to develop family hubs for the length of childhood and into young adulthood? With finite resources, will it be hard to maintain the momentum for family hubs to offer support at the **earliest point** in a child's difficulties, in favour of support in the **earliest years** of a child's life?*

*This early 'point' may be an anxious teenager struggling to attend school; a group of school aged siblings whose parent has just been diagnosed with a life limiting illness; a twenty year old Autistic whose struggles in the workplace are impacting on family at home. Each of these scenarios are repeated throughout the region and in a myriad of different ways and each would benefit from advice, signposting or intervention at the earliest opportunity through a family hub approach.*

*Can you make a strong argument for your local family hub approach in relation to the whole child 0-19/25? How can your data support your case for the whole child? How does your local data demonstrate improved outcomes in the longer term for families, and as children grow up, when you have been able to make a great offer for the first 1001 days?*

Do you have something on your mind about Family Hubs? Are you playing with ideas in your head about how to improve services for families in your area? Do you have a burning issue that might challenge other people's thinking? We would really like to encourage you to contribute a short blog of between 100-300 words that might help to shape our thinking about Family Hubs and how to implement them in the South East so do let us know if you have something to share. You can let us know if you would like your blog to be anonymised or if you would like to have your name published with your work.
