



The Leicester Journey...

- 2015 Inadequate inspection Lead member and Director sacked
- 2015 2017 Monitoring visits, DFE involvement, Improvement board, huge changes and challenges.
- 2017 Requires Improvement judgement by Ofsted
- 2017 2021 Poor SEND review, continual challenge, DCS changes, our own improvement board (independently chaired), COVID.
- 2021 GOOD inspection outcome
- 2021-2022 Striving for Excellence but constantly worrying about staying good!

What did Ofsted say?

Inspection date: 14 January – 4 February 2015

Report published: 20 March 2015

The overall judgement is that children's services are inadequate

There are widespread or serious failures that create or leave children being harmed or at risk of harm. Leaders and managers have not been able to demonstrate sufficient understanding of failures and have been ineffective in prioritising, challenging and making improvements.

It is Ofsted's expectation that, as a minimum, all children and young people receive good help, care and protection.²

The judgements on areas of the service that contribute to overall effectiveness are:	
1. Children who need help and protection	Inadequate
2. Children looked after and achieving permanence	Requires improvement
2.1 Adoption performance	Good
2.2 Experiences and progress of care leavers	Requires improvement
3. Leadership, management and governance	Inadequate

"There has been a corporate failure of leadership to a point where children are no longer adequately protected."



Follow the money

- Investment £2.4m to support improvement
 - £1.2m each year
 - Tracked monthly
 - All new commitments had to demonstrate what they would add long term
 - Included external auditors, performance specialists, senior capacity
- Development of the cross-service Multi-agency CSE Missing Trafficked Hub
- Halford House Accommodation Children's social care fieldwork
- Permanent funding into placement budget and staffing structures to safeguard children/young people
- Grow our own
- Temporary funding to recruit level 2/3 social workers to support newly qualified social workers (over establishment)
- £500k investment in Signs of Safety practice framework
- Deployed resources from across support services to work with children's services
