USEFUL INFORMATION

SE19 SEND Peer review - Courageous Conversations

The region is developing an approach to peer review that is intended to provide opportunity for supportive, candid conversations around SEND delivery in the local area. Areas will be asked to identify one area of focus and will be supported by regional colleagues to carry out a review of delivery and identify ways forward. The approach is intended to help both the reviewers and the reviewed. It will explore what is not working and build upon what is working. The focus of the conversation is intended to be be agreed with the area's PCF.

There will be a trial of the approach in the Autumn and it is hoped to offer all areas an opportunity to be involved over the next two years. There will be more information and sharing of experience in future SE19 SEND forums.

Internships Work Programme

The region is engaged in the Internships Work programme, a three year funded programme by the Department for Education (DfE). It is being delivered in partnership by the National Development Team for inclusion (NDTi), The British Association for Supported Employment (BASE) and DFN Project Search.

Internships Work aims to support more young people with SEND into employment through doubling the number of internships available to young people with EHCPs.

All LAs in the region have a grant from the DfE to support the development of pathways to employment until the end of March 2025.

There is free training and support available for all LAs through the programme for staff development and training.

SEN 2 Statistical Release

This year's <u>SEN 2 statistical release</u> has recently been published. The information collected through the special educational needs survey (SEN2) provides the major source of data collected on children and young people with Education, Health and Care (EHC) plans. It is the only source of data on the totality of EHC plans maintained by individual local authorities (LAs).

A 'person level' collection has been done for the first time this year. The person-level return provides additional information on children and young people with EHC plans including adding gender, ethnicity, and type of need to the information already collected (age and setting types).

The data illustrates the growth in demand over the past year and the challenges faced by Local Areas in responding to the changing landscape.



Key headline stats;

1. The total number of EHC plans has continued to increase

The number of plans now stands at 517,026, 9% more than last year and 62% more than the equivalent figure (the combined number of plans and statements) five years ago.

2. The number of assessments completed in the calendar year has also increased There were 72,695 assessments completed during 2022, 10% more than the previous year and 61% more than five years ago.

3. The number of requests for new assessments has increased

There were 114,457 requests for new assessments during 2022, 23% more than the previous year and 69% more than five years ago.

4.The timeliness of the issue of new plans has decreased from 59.9% to 50.7%. Prior to this year, there has been little change over the last five years, with rates around 58-60%

- what lacking mental capacity means and the decision-making principles
- · the changes to decision-making when a child reaches adulthood
- the relevant route for you to make financial decisions on behalf of a young person, including how to access a Child Trust Fund
- if the young person is under the age of 18, how to prepare to make financial decisions when they reach adulthood

New CDC resource: Ofsted and CQC Area SEND Inspection Local Area Readiness Checklist

Based on work undertaken with a local area, CDC have published a new resource aimed at supporting local areas to prepare for Ofsted and CQC SEND inspections. The resource takes the form of an inspection checklist, which is a simple tool that will support local areas in gathering and preparing all the relevant information that will be requested during a SEND inspection. The checklist is based on the new SEND inspection framework and handbook.

The checklist sets out the information that the inspectors will request to enable them to get a sense of a local area's SEND arrangements and practice, as well as assist them in selecting children and young people's cases for tracking, and the further information they will request about those selected. Inspectors may request some or all of the information for monitoring inspections. The checklist also sets out the high-level timeline for sharing information.
