## Supported accommodation

- We agreed to regulate supported accommodation for looked after children and care leavers aged 16 and 17 in December 2021
- Supported accommodation regulations came into force on 28 April – we started to accept applications to register on the same day
- To legally operate, existing providers must have been registered (or have submitted a complete application to register) by 28 October 2023
- We begin inspections in April 2024

'We know that for some looked after children and care leavers, supported accommodation can be the right choice as they move into adult life. But although there are some examples of excellent support, this just isn't consistent across the board.

New standards and oversight are absolutely necessary, so I'm pleased that Ofsted has been asked to develop a regulatory system and inspection framework for supported accommodation. All young people deserve to live somewhere they feel happy and safe, which is why we are developing a system that places the interests of young people at its heart.'

### Care and support



- Supported accommodation does not provide 'care' to children in the same way as a children's home does but young people's needs cannot always be easily categorised under either 'care' or 'support' – these are part of a complex continuum
- High-quality supported accommodation should be caring, kind and nurturing
- If a young person is living in supported accommodation, we will expect to see that this is demonstrably in their best interests and the support meets their individual needs
