

# SESLIP AD Education Network Update: February 9<sup>th</sup> 2024

# In Today's Update:

- <u>DfE</u>: Ofsted's thematic review of AP calls for major reforms, Ofsted's changes following its response to the death of Ruth Perry, post-16 and KS4 performance data by MAT, wraparound childcare guidance for schools, net capacity tool for schools, DfE's annual accounts and report for the academy sector, final list of SE schools with RAAC and category for resolution.

- News: Reading BC's response to the Ruth Perry coroner's report, minister swipes at 'some LAs' over RAAC, investigation into '2x RI' policy with school leaders calling for it to be abandoned, DfE exploring alternative progress 8 measures, DfE pauses any changes to EBacc attainment measures, HoC committee calls for reform of LA funding (incl SEND), difficulties recruiting EPs adding to EHC needs assessment backlog, large increase in crisis CAMHS referrals, MAT P8 and A\* performance pre and post-covid, apprenticeship degrees won't address current teacher recruitment difficulties, many more pupils with EHCPs could be in mainstream schools according to DBV programme.

#### 1. DfE:

- Ofsted thematic review of alternative provision (AP), drawing on evidence from review visits to 6 LAs and evidence from SEND inspections. The report is critical and calls for major reforms, stating too many young people have negative experiences in AP. ### 2. Reports:

- New tool and accompanying report offers a method for groups of schools to assess how inclusive they
  are in comparison to other groups, taking into account attainment as well. Among the findings in the
  report are that larger MATs (with 10 or more schools in a phase) have, on average, higher rates of
  persistent absence, suspension, and unexplained exits than smaller MATs and local authorities.

- Auditors publish their 2024 overview of MAT annual accounts based on 300 trusts. The report flags
  that nearly half of trusts had to use their reserves in the past year to balance their budgets. 1 in 5 now
  have reserves below the level required in their reserves policy, whilst 40% of larger trusts report the

- Discussion paper about what is next for the professional development of school leaders. Whilst
  recognising the positive steps there have been with a core curriculum of NPQs, the paper calls for
  focus now on the approaches and means to support leaders develop their skills and craft.

## 3. Research:

 Paper drawing on interviews with young people and algorithmic analysis to conclude that social media sites promote more extreme views through gamification. This risks normalising misogynistic views and other extreme views among young people. "Young people now exist in hybrid realities that are woven between their online and off-line worlds. Schools face unprecedented challenges in this area and outright bans are likely to be ineffective."

#### 4. News:

- As part of its response to the death of headteacher Ruth Perry, Reading Borough Council has
  committed itself to carry out an annual survey of headteachers wellbeing. It will also develop and
  publish a policy on taking a more robust approach to Ofsted inspections.

- Minister acknowledges that there is a perception problem among schools about becoming a converter academy. She wanted to stressed the positives of being in a strong trust and also claimed some maintained primary schools with RAAC were not well supported by their LA.

- Investigation into DfE's 'coasting schools' policy and the 469 letters issued since its initiating in Sept 2022. - The DfE is considering alternative ways to calculate progress 8 scores, in the absence of KS2 data during lock-downs. - DfE pauses its plans to alter KS4 attainment measures to encourage greater uptake of EBacc subjects.
  The revised guidance states: 'current EBacc APS will remain the headline EBacc attainment measure'.

- Coverage of the inquiry report from the Levelling Up, Housing and Communities Committee which highlights how precarious LA finances are. As part of its recommendations for an overhaul of local



government financing is a call to review SEND funding where strategies at the moment are not achieving any significant reductions in costs. - Following its ruling about delays in an EHC needs assessment in Surrey that were compounded by shortages of EPs, the Local Government Ombudsman has written to Surrey CC about its response. - Figures from the Royal College of Psychiatrists points to a 53% increase in referrals to CAMHS crisis

  includes some focus on MATs including changes across the larger trusts informed by some contextual

- Whilst any initiative to increase numbers training to become a teacher should be welcomed, the
  newly announced teaching degree apprenticeships will take many years to make any difference to the
  current recruitment difficulties. Professional associations are calling on the DfE to increase salaries to

- Coverage of Newton Europe's insights reporting from its support for SEND DBV programmes.
   Specifically it challenges that many more children and young people with an EHCP should be educated in mainstream schools provided there are improvements in ordinarily available provision.
