'this research does not seek to evidence best practice in its own right but to recognise the variance of kinship in practice and approach and, from knowledge gained, set out a proposed model of good practice, one that is responsive to the findings and could be adopted within local authorities in England'

'whatever changes are made at a government level, and whatever local guidance is issued around kinship care, the importance of how this is then enshrined into local authority policies and then manifested in social work practice, is likely to be an area of challenge for a significant time to come'



### National Kinship Care Strategy summary

The first ever National Kinship Care Strategy for England has been published, setting out the Government's plans for kinship care, including new commitments and £20 million investment over 2024-5.

The Government committed to delivering a dedicated kinship care strategy in February 2023 when it published its *Stable Homes, Built on Love* plan for children's social care. Our **#ValueOurLove** campaign has mobilised thousands of kinship carers over the last year to write to Ministers, meet with their MPs, and share their views and experiences through consultations to push the Government on their commitments to kinship families.

Below, we've outlined each of the new commitments made in the Strategy. Each is a testament to all the kinship carers who have demonstrated, for decades, the value of raising children within their family network, but overall the Strategy doesn't go far enough to deliver the urgent support kinship families need now and build a new kinship care system for the future.





## **Background to the ASGSF**

The Fund has provided much-needed, life-changing therapeutic support since its inception in 2015.

The need for the fund emerged out of recognition of the challenges faced by adoptive families and the resulting trauma requiring comprehensive support.

The fund provides one element of this support and has had a transformative impact for many families; preventing the risk of disruption and providing a consistent support offer for families across England.

The fund is aimed at improving the lives of children and young people both now and into the future.



## The ASGSF Journey



## The ASGSF so far

## How does the ASGSF work?

#### **Pre-Application Process**

- Local authority to complete a review of support needs.
- They will talk to you about the services you/your child can access.
- They will talk to you about the providers available.
- Once agreed they can apply for funding.

#### **ASF** Application

- They complete the ASF application on your behalf.
- The application will be reviewed against the scope and eligibility criteria.
- A decision will be provided to the LA within 25 working days of the application submission.

- If the application is approved they
- commission the services identified. Services can be delivered to
- you/your child.

## **ASGSF Criteria and Eligibility**

#### Do you have an SGO or Child Arrangement Order?

Children previously looked after by the local authority can access funding for therapeutic services. Your local authority or regional adoption agency can provide further advice around eligibility and if you meet the criteria, they can complete an application on your behalf.


#### Is my child eligible?

The ASF is available to children up to and including the age of 21, or 25 with an education, health, and care (EHC) plan who were either:

- looked after by the local authority before a SGO was made;
- looked after by the local authority before the SGO was made but subsequently changed to an adoption order, or vice versa;
- looked after by the local authority prior to living under a child arrangement order (CAO) to enable the assessment of a potential special guardian. They remain eligible if an SGO is subsequently made.

## What can the funding be used for?

### Creative therapies (e.g. art, music, drama, play therapy)

Creative ways for your child to process their thoughts, feelings and history through therapy.

### Extensive therapeutic life story work

Helping your child understand and cope with their past trauma and difficulties through therapy.

#### **Family therapy**

Therapy to help build attachment and improve the relationship between you and your child

#### **Therapeutic Parenting**

Group training/individual sessions to support you with skills and techniques to therapeutical parent your child.

#### Psychotherapy

A talking therapy for your child to help them understand and cope with their past trauma and difficulties through therapy.

#### **Specialist Assessments**

In-depth assessment of your child and family's needs focused on trauma and attachment completed by a qualified clinician resulting in a therapeutic support plan.

#### Do you have an SGO or Child Arrangement Order?

#### Did you know that you may be eligible to access ASF funding?

Children **previously looked after** by the local authority can access funding for therapeutic services. Your local authority or regional adoption agency can provide further advice around eligibility and if you meet the criteria, they can complete an application on your behalf.

#### Is my child eligible?

Championing Kinship Care: The National Kinship Care Strategy

In February 2023, DfE published Stable Homes, Built on Love to respond to the Independent Review of Children's Social Care.

In December 2023, DfE published Championing Kinship Care. Government has invested  $\pm 20m$  of funding in 2024-25 to ensure there is well designed improvement across the kinship care sector so that kinship carers and children in kinship care arrangements feel supported, empowered, and heard.

As part of this, £3.8 million in 2024-25 to expand the role of Virtual School Heads to ensure that more children in kinship care receive the help they need to thrive at school

## **Kinship Care**

Kinship care includes children who may be living in an informal arrangement made by their parents, on a Child Arrangements Order or Special Guardianship Order, 'looked after' by the local authority and placed with kinship foster carers.

The remit of virtual school heads already includes kinship children:

- who are looked-after
- who meet the definition of previously looked-after
- with a social worker.

Virtual school heads should bring greater focus and visibility to the distinct needs of children in kinship care within their existing non-statutory responsibilities of CWSW. The **VSH non-statutory duty** will be extended to specifically include championing the attendance, attainment and progress of children in kinship care from September 2024 to bring parity of support to kinship families who are currently not captured.


## Additional activities for the extension to kinship care



Enhancing partnerships between education settings and the local authority so agencies can work together in a child focused manner



Identifying the needs of the cohort and addressing barriers to poor educational outcomes to ensure pupils make educational progress



Offering advice and support to key professionals such as social workers, designated teachers, designated safeguarding leads (DSL) and school leaders to help children make progress, including through increasing their confidence in using evidencebased interventions.



Raising awareness of the needs and disadvantage of children in different types of kinship care arrangements



Promoting practice that supports attendance and engagement of kinship children in education



Promoting practice that improves the educational attainment of children in kinship care



Expand the provision of advice and information, on request, to all kinship carers with special guardianship orders and child arrangement orders, regardless of whether their child was previously looked after by the local authority.
